the context be deemed to mean and include the Trustees or Trustees for the time being of these presents and their successor or successors in office) of the **OTHER PART**.

WHEREAS the 78, Chittaranjan Avenue, in the town of Calcutta within aforesaid jurisdiction out of humanity and natural love to the society is desirous of settling the TRUST, of handing over a sum of Rs. 10,000/- (Rupees Ten thousand only) to the **TRUSTEES** with the intention that they shall hold the said sum and income arising therefrom **TRUST** subject to the power and provisions hereinafter/herein Group declared of convening the same which the **TRUSTEES** have agreed to do and all the donation contributions, additions, accumulations to the said money and conversion thereof and invest in which the same way from time to time be invested and all other moveable properties and assets that may from time to time be invested in the Trust or be received by them by way of donations or acquired by them or may come into their hands by virtue of these presents or by otherwise howsoever in relation to the Trust hereby created,

hereinafter referred to as "**THE TRUST FUND**" i.e. the "Trust Property".

AND WHEREAS with a view to and for the purpose of constituting the Trust permanently for the purpose of carrying on the objectives of the Trust as mentioned hereafter under the "Aims and Objects" clause of this Deed of Trust, it is considered desirable that for the purpose of creation of this Trust the declaration of the Trust should be made in the manner set out hereunder.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS

1(a) **NAME OF THE TRUST:- "BINDOLE SWAPNAPURAN TRUST.**

(b) The Registered Rented Head Office of the Trust be located at Villagers Pariharpur, Post Office- Bindole, P.S. Raiganj, Dist. Uttar Dinajpur, West Bengal, Pin-733156, The Board of Trustees shall have the right to shift the office to any other place in West Bengal or to any other state or open local office or offices at Places deemed necessary.

2. **INTERPRETATION:**

- a. Trust means the Trust created by this "**BINDOLE SWAPNAPURAN TRUST (A PUBLIC CHARITABLE TRUST)**".
- b. The Board shall mean the Board of the members which may be filled up by co-option of the existing Trustees created by this Deed with renowned and suitable persons.
- c. **TRUST PROPERTY** shall include every kind of property moveable and immovable to be owned by the Trust and mentioned in accounts, books and other documents in the possession, custody and control or that ought to be in the possession, custody and control or possession of the Trust.

3. **OBJECTS OF TRUST:**

- a. To perform that notwithstanding herein contained in the income as the corpus **OF THE TRUST** fund the same shall be applicable and applied to for **PUBLIC CHARITABLE PURPOSE ONLY** within such territories and subject to such conditions or limitation if any as may from time to

time be laid down by the Income Tax Act, 1961 or any other Acts governing taxation of income the wealth of **PUBLIC CHARITABLE TRUSTS** so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or Acts, now or prevailing or any modification replacement thereof:

- b. To Act in such a way that the TRUST hereby established shall always retain the status of one such **TRUST** to which the provisions of section 80G/35 AC/10(23C)IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor.
- c. To promote, establish, start, maintain, organize, run, manage, supervise, superintendent, co-ordinance, affiliate, control, guide and grant aid to schools, colleges, universities, hostels, laboratories, libraries, theatres, auditorium, lecture halls, exhibition, reading rooms, training institutions, practical classes, and other

educational institutions for the promotion of the arts, literatures, science and commerce, to provide free post educational support i.e. facing interviews, competitive exams guidance, job-oriented computer training to the needy and meritorious rural people, to impart grass root education by establishing nursery and primary schools for children, moulding and shaping their minds as they are the greatest asset of the future generation, to establish vocational training institutes and enhance the skills of the people in backward areas, to establish reading rooms, libraries, laboratories, hostels, research centers, career guidance cell, book bank, free coaching institutes for the students of primary classes to civil service examinees, to provide online information to people all over the world regarding various courses, higher studies, job prospects etc., to conduct Talent Search Competitions, to help the needy students for pursuing higher studies, To recommend students for award of scholarships and fellows-hips etc.

- d. To construct mosque, madrashahs, orphanage etc.

- e. To establish, maintain, control, manage and or render financial assistance to hospitals, health centres, nursing home, dispensaries, maternity homes, clinics, sanatorium and other establishments for providing medical facilities and to promote medical research in these centres in all faculties and systems of medical practices and provide medical help including supply of medicines providing Ambulance services, arrangement of medical van and medical unit to the public irrespective of any caste, colour and need and to promote research for medicines for cancer and other incurable diseases. To organize medical camps in remote areas and arrange spectacles or other medical aid for needy. To provide Health Card to each members of the Trust who will get benefit from our member hospitals, nursing homes, polyclinic, diagnostic centres etc. Health awareness programme to pregnant lady and lactating mothers, about their proper diet guidelines in different stages, awareness on different physical problems appeared during pregnancy and lactation, such as Anaemia, Toximia etc. and to overcome them through proper food habit,

sketch out the required amounts of foods. (Energy giving food, Body building food & Protective food) in different stages, proper hygiene during pregnancy & lactation, guide lines to bring up a child with proper nutrition. Discussion done in the seminar on polio, Osteoporosis, Xerophthalmia, Rickets etc. Fight against AIDS. Eye Camp. Etc.

- f. To start, support, organize and give financial aid to the social, cultural and moral renaissance of the people and to develop physical, mental and educational capacity of the society and to promote schemes for such purposes:
- g. To organize and undertake social welfare programmes and activities to foster social unity and to reform the society through moral and ethical movements for awakening of the self in relation to the society and to organize the dedicated youth to serve the suffering of humanity:
- h. To establish, maintain and grant aid to institutions for the relief of the poor and advancement of education for the

aforesaid purpose or purposes and to grant periodical and other occasional help to the deserving persons:

- i. To do any other act for the advancement or general public utility without distinction or discrimination of sex, colour, caste, creed or religion:
- j. To grant relief on the occasion of famine, earthquake, other epidemic and other occasion of calamities of similar nature and to give donations, subscriptions, or contributions to the institutions, establishments or persons during relief work on such occasions:
- k. To undertake traditional and experimental activities for the welfare of the children, women, handicapped, blind persons and destitute in the social structure:
- l. To establish, maintain, control, manage and give financial aid to orphanages, widow-homes launce, asylum home for destitute and insane persons and other establishments for relief:

- m. To organize, hold and/or arrange to hold seminar, function, workshops, conferences, lectures, debates, recitations, symposiums and other cultural and literary programmes and social gatherings by inviting men of eminence and scholars of outstanding national and international reputation for the same for the promotion of the aforesaid objects of the **TRUST**:
- n. To grant scholarships, stipends, awards and prizes, financial aid and assistances and other emoluments to students, research workers and to undertake any research works for the attainment of the objects of the **TRUST**.
- o. To plan, implement and supervise development programme for the upliftment of rural economy:
- p. To create scope for employment by promoting small-scale, cottage, and village industries in the villages and rural areas:

- q. To organize self help group formation, micro-credit and micro-finance training and seminar for the upliftment for the rural economy:
- r. To co-operate with the Government and Non-Government organization for any developmental activity of the rural and urban areas:
- s. To raise resource and funds from any sources as consistent with the principals and objects and in conformity with the interest of the said TRUST:
- t. To co-operate and connect with national, organizations, having similar objectives and reputes or receive representatives from such organizations:
- u. To work for development of social welfare, health and education for the children of rural and urban area:
- v. To work for development of community awareness and vocational education for the rural women:

- w. To organize seminars, workshop on forum for environmental programme, plantation /national intergration etc. and to observe the birth day of National leaders with holding Mela/ Exhibitions/ Debates:
- x. To perform work on progress of knowledge for rural people and to establish and maintain libraries, reading rooms, adult literacy classes, for educational technical, agricultural or medical knowledge:
- y. To cultivate the art and culture and habit of living and working together to enhance fellow feelings activities and integrated activity:
- z. To promote social, civic, moral activities to take care for orphans or of aged helpless man/woman:
- aa. To arrange functions, spiritual sittings, exhibitions etc. for the progress of arts, literature, science, culture etc. in the rural and urban areas:

- bb. To develop and improve medical activities and facilities to rural people with providing medical support to sick, helpless handicapped people, to establish charitable dispensary, health centre old age home etc:
- cc. To seek receive and take any subscription or gifts or donation of all kinds like money or property both moveable or immoveable donated by any organization or individuals either in INDIA or abroad for any of the objects of the TRUST:
- dd. To help or to co-operate to individuals or associates or clubs or any other organizations, to establish and to maintain any/or all the objects of the TRUST and to help and to issue affiliation to any similar organization either in establishing or in their work progress only after getting Indemnification Bond from them and cancel their affiliation in case they engage themselves in any wrongful/illegal activity and their cancellation shall be published in Newspaper:

- ee. To create job opportunities for the local/zonal and other people by establishing S.S.I. Unit/Handicraft Unit/Medical Sub-unit/Home Industries for the development and upgrading economy of the unemployed youth of both sexes, handicapped, orphans and other categories of people, knitting, tailoring etc. and to organize training programmes for such developmental programmes, issuing C ertiificates after training courses for the benefit of the trainees, concession, for training periods, in Govt, bus & train, only for the poor students:
- FF. To promote all kind of research projects on modern science and technology, to establish rural center for snake-biting treatment and for research work upon thin subject:
- GG. To perform jobs relating to prevention of atrocities or cruelty on animals:
- HH. To work for the promotion of Yoga and Naturopathy:
- II. To establish rural museum for upkeep and preservation of age-old sculptures, work of art etc:

- JJ. To establish rural libraries for providing text books to the rural students living below the poverty line:
- kk. To organize creche, vocational homes, residential schools, family planning programme I.C.D.S. and other Government programmes, extending schemes as the TRUST BOARD may deem fit and proper:
- ll. To undertake housing and resettlement activities for economically or otherwise disadvantaged people in rural and urban areas by way of concept formulation surveying planning supervising, producing of low cost and innovative building materials, construction, financing, management, research and development and/or training:
- mm. To raise fund by way of loan, donations, fees etc. from any person/s, the state or central Government Organisations, companies corporate agencies, institutions or otherwise for the TRUST and/or to provide funds to such beneficiaries as many be identified by the TRUST:

- nn. To arrange for a conservation of such parks where rare species of animals and birds breeding and bird rescue centre, shall remain and growing and take care of them shall be done for gathering knowledge by student of school and colleges:
- oo. To arrange Haj Training Centre and/or take necessary steps for the smooth management of the Haj Jatri regarding their passport, Visa, accommodation and ancillary works.
- pp. To organize and establish Research Centres, Fiqha Academy, Darul Ifta, Darul Qaza and such other institutions for the promotion or moral values in the day to day life.
- qq. Renewable Energy Projects like Solar, Sind, Bio-mass/Bio-gas, Horticulture /Floriculture/ Vermi-culture /Pisciculture/ Animal Husbandry/ Medicinal Plants/ Sericulture Projects etc. in the rural areas:

- rr. To take up any Water-shed management projects in the adjoining areas:
- ss. To propagate the idea of integrated social development in all possible manner
- tt. To establish the training center on Youth Development, Demonstration Projects, Tourism resorts in various parts of INDIA:
- uu. Family planning as well as Socio-development option also shall be taken as deem fit to help the rural population in the succeeding years to come:
- VV. To use the profits of surplus income for the developmental activities but shall not be distributed among the TRUSTEES:
- ww. To work for all round development of SC/ST and O.B.C. community:

4. ADMINISTRATION;

The properties and funds shall vest in the name of Trustees constituted by persons executing the Deed of the Trust. The

number of members of Board of Trustees shall not exceed 11 (eleven) and the vacancies can be filled by co-option by the existing Trustees.

5. OFFICEBEARERS:

Office bearers of the Trust shall be initially as follows:

The Board of Trustees is also Empowered to create any office bearer post and elect other office bearers to fill up the post from the Trustees and/or from outside the Board of Trustees.

The above Office-bearers shall be elected by the co-option of the Trustees at a meeting convened for the purpose.

6. VACANCIES;

A vacancy shall arise among the Trustees in the following cases -

- I. When a Trustee dies;

- II. When he resigns his office as a Trustee;
- III. If he becomes Bankrupt,
- IV. If he becomes in sane or otherwise become incapable to act
or
- V. When he is absent from three consecutive meetings of the Board, unless the Board records condoning such absence in the minutes of the meetings of the Board of Trustees for substantial cause; VI. When it becomes insolvent;
- VI. When convicted of any criminal offence involving moral Turpitude;
- VII. When he acts or does anything detrimental to the interest of the Trust;
- VII. On medical evidence when he is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose.

7. FUNCTIONS OF THE OFFICE BEARERS:

7.1 PRESIDENT:

- I. President **WILL BE ELECTED BY THE MAJORITY OF THE MEMBERS** trustees present in the meeting convened for the purpose.
- II. The president is empowered to take decisions on urgent matters, but such decisions should be approved by the Board within a period of 30 days.
- III. The President will preside over the meeting of the Trust and conduct the proceedings.
- IV. The President in his own decision or by the request of the third of existing members can call for the meeting of the Trustees.
- V. The President is empowered to delegate such powers to any other members of the Trust as he may deem fit.
- VI. The President is empowered to dissolve the Committee or the Board in any abnormal situation.

7.2. GENERAL SECRETARY;

The General Secretary who will act as managing trustee of the Board of Trust, elected under the control and supervision of the Board, shall conduct and manage all the

affairs of the Trust, its all properties and institutions, sign papers and carry on the response on behalf of the Trust, and shall be responsible for the safe custody of records of the Trust, and keeping of the proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time by the Board provided that in the absence of the General Secretary. The President, the Vice- President of the Assistant General Secretary or any other Secretary especially authorized on that behalf may sign papers and carry on correspondence on behalf of the Trust and do all or any of the duties relating to the General Secretary under this clause. The General Secretary shall attend to the correspondence and today affairs of the Trust. The General Secretary shall carry out all the resolution of the Trust and for that purpose he shall have power to incur necessary expenditure from and cut of the funds of the Trust, subject to a maximum of Rs.5,000/- (Rupees Five Thousand) only and anything in excess of Rs.5,000/- (Rupees Five Thousand) only is to be incurred with the sanction of the Board. He shall have the

custody of the correspondence and other books relating to the affairs of the Trust.

7.3. ASSISTANT SECRETARY;

The Assistant Secretary shall assist the General Secretary in all affairs of the Trust. In absence of the General Secretary and on request he will have the powers and to perform duties of the General Secretary.

7.4 TREASURER;

The Treasurer shall conduct and receive all sorts of subscriptions, donations and deposit or money and grant receipts of money thereof. He will maintain and keep cash book and such other books of accounts as are necessary.

7.5 MEMBERS:

Member means who are willing to act under the board of trust but he will not be treated as beneficiary or trustee of this instant trust.

7.6 NO PERSON BEING : -

- A. an undercharged insolvent; or
 - B. convicted of an offence involving moral turpitude; or
 - C. of unsound mind; or
 - D. a minor;
 - E. shall be eligible to be a Trustee.
8. The Board of Trustees may, by a unanimous vote of all the Trustees for the time being except the Trustee proposed to be removed, remove any Trustee, permanent or otherwise, from office after finding the Trustee proposed to be removed guilty of serious misconduct in relation to or converging the trust estate or trust estate or trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in within the continuance of the Trustee proposed to be removed as Trustee or these presents was desirable keeping to the object of the trust in view other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the Trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges

leveled against his for his removal and the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called any question anywhere.

9. APPOINTMENT OF THEIR EMPLOYEES:

They shall have also power to employ necessary staff for management, administration and running of the Trust in general and of institution in particular on such reasonable salaries and remunerations and on such terms as may be appear proper to the Trustees for managing the affairs of the Trust and the Institutions and for the purpose of achieving of the objects of the Trust. They may be allotted or entrusted with such duties and responsibilities.

- 10. THAT** the TRUST shall have the bank account with any nationalized bank/s /Private bank and shall be operated by two TRUSTEES namely General Secretary and Treasurer of the Trust.

11. **THAT the TRUSTEES** may engage themselves and carry on any business for and on behalf of the TRUST established by this Deed and may invest any part of funds or assets of the TRUST fund in such business or Businesses for the benefit of the beneficiaries and in such case individually that TRUSTEE shall remain responsible for his wrong and loss and for this the TRUST MANAGING TRUSTEE and the SETTLER shall remain indemnified:

12. **THAT the TRUSTEES** shall maintain the true and fair accounts of the TRUST FUNDS, receipts and disposed of or spent and all matters in course of management of this TRUST, in respect thereof or in relation to the carrying out of the object and effects to the TRUST PROPERTY. The accounting year of the TRUST shall be accounted for i.e. from 1st April to 31st March, of each English calendar year:

13. **THAT** the number of TRUSTEES shall be not less than 2 (Two) and not more than 11 (eleven). If there shall be any

vacancies of the office of the TRUSTEES the same shall be filled up by the continuing remaining TRUSTEE or TRUSTEES by the process of nomination in consultation with and acceptance of the SETTLER.

14. **THAT** the TRUSTEES shall have the full power to compromise or to compound all actions against such suits and settle all accounts relating to the TRUST PROPERTY and to do all suits and settle all accounts relating as fully and effectually as if they were absolutely entitled to the TRUST PROPERTY without being liable or answerable for any loss thereby:

15. **THAT** the receipts of the TRUST for any money, stocks, funds, shares, securities or investments paid, delivered or transferred to them in execution of the TRUST or power hereof shall effectually be released and discharged the persons paying delivering or transferring the same:

16. **THAT** the TRUSTEES jointly shall be responsible for such money, stocks, shares, funds and securities as they shall actually receive notwithstanding their respectively signing a receipt jointly with others for the sake of conformity and shall be answerable and accountable for the account, receipts, neglects and any banker, broker or other person or persons with whom or whose hands any TRUST moneys or securities may come or be deposited or given or for insufficiency or deficiency of any stocks, shares, funds or other securities nor for any other loss unless the same shall happen through their default or negligence respectively:

17. **THAT** the TRUSTEES shall reimburse and pay and discharge out of the TRUST FUND all expenses incurred in course of the execution and administration of the TRUSTEES and in uses or for carrying out their duties under these presents but they shall not be entitled to any honorarium or salary for the TRUST:

18. **THAT** one of the trustees referred to herein as General Secretary through out his life time shall remain as the MANAGING TRUSTEE of this TRUST, having the general control and supervision of the TRUST and the MANAGING TRUSTEE shall manage the TRUST FUND and carry on all the affairs of the TRUST.
19. **THAT** in case of difference of opinion among the TRUSTEES decision of the majority TRUSTEE as the case may be shall prevail and by every three months meeting of the BOARD OF TRUSTEE shall be held and evaluation of the works of each member of the BOARD OF TRUSTEE shall be made in the annual meeting of the BOARD and in that meeting ineffective member of the BOARD shall be expelled in proper system:
20. **THAT** any TRUSTEE may delegate in writing all or any of his or her powers under these presents to his or her CO-TRUSTEE as nominee who will be entitled to exercise such power or powers, in the same manner as the TRUSTEE

himself could do personally notwithstanding anything herein contained the TRUSTEE shall be entitled to use the name of the TRUST in connection with any matter relating to the said TRUST and for the purposes the said MANAGING TRUSTEE for the TRUST shall appoint, dismiss and reappoint any staff, manager, lawyer, advisor, advocate, auditor and substitutes and pay their expenses and fees as shall be deemed reasonable from time to time and for the purposes of the said matters and actions in Courts or otherwise the TRUSTEES or any of them or the MANAGING TRUSTEE shall be entitled to sign and verify all complaints, petitions, pleadings, written statements, memorandums, Vakalatnamas powers the TRUSTEES or any of them shall be entitled to appear for and on behalf of the TRUST and give evidence orally or adduce any evidence and take necessary proceedings, on the said matters and actions:

- 21. THAT** a resolution in writing circulated amongst all the TRUSTEES duly signed by them shall be valid and effective

as if it has been passed at a meeting of the TRUSTEES duly called and convened:

22. **THAT** any of the TRUSTEES may retire from trusteeship if he or she so desires, but with acceptable reasons:
23. **THAT** the power to appoint/nominate new or additional TRUSTEES so as not to exceed the maximum number of TRUSTEES existing herein and to fill vacancy in the office of the TRUSTEE shall vest in the continuing TRUSTEE or TRUSTEES:
24. **THAT** on a new TRUSTEE being appointed/nominated on his signing the Minute Book to holding the effect of his possession of the TRUST PROPERTIES shall vest in him along with the other TRUSTEES for the time being and he will be entitled or to carry out the duties and function of a TRUSTEE:
25. **THAT** for amendment or change of any clause of this TRUST DEED the MANAGING TRUSTEE shall prepare it and get in accepted by the BOARD OF TRUSTEE: THAT in

The trust will never acts like Micro financing and Money Laundering (Act 2012) Economic offence/crime in connection with sec 20 and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA Act from the Central Govt./ the competent Govt, authority which the trust and the trustees are responsible for tha and come under the all punishable law (CRPC and IPC)

29. APPLICABILITY OF TRUST ACT:

The provisions of the Indian Trust Act 1882 (Section 4) shall apply to all matters not specifically mentioned in these presents.

30. LAWFUL PURPOSE -

A trust may be created for any lawful purpose. The purpose of a trust is lawful unless it is -

(a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the Court regards it as immoral or opposed to public policy. Every trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is other unlawful and the two purposes cannot be separated, the whole trust is void.

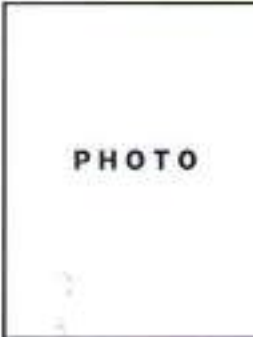
